

# The Bartos Ballot

In the 2015 General Election, Jeff Bartos colluded with party bosses and establishment insiders by paying for the mailing and distribution of a Republican sample ballot which excluded the names of Republican nominees as chosen by Pennsylvania's registered Republican voters in the Primary Election.

On the ballot funded and issued by Jeff Bartos, Pennsylvania Supreme Court Republican Nominee Anne Covey and Montgomery County Commissioner Republican Nominee Joe Gale were omitted.

**Ultimately, The Bartos Ballot helped the Democrats win three seats on the Pennsylvania Supreme Court and maintain control of the Montgomery County Board of Commissioners.**
