Dear Mr. Connolly:

This letter acknowledges receipt by the Office of Attorney General (OAG) of your written request for records under the Pennsylvania Right-to-Know Law, 65 P.S. § 67.101 et seq. (RTKL). Your request was received by the Right to Know Office on March 18, 2024. Therefore, under the RTKL, a written response to your request must be mailed on or before March 25, 2024. This letter is provided pursuant to that requirement. For purposes of this letter, the "identified records" are those in your request, as modified by any subsequent communications.

Your request indicates that you are seeking the following information:

- Please provide All financial donation records provided by Entities and Individuals to Josh Shapiro, and his Subordinate Special or Attorney Agents, including Consumer Protection, and Criminal Investigation Agents that provided financial donations or assistance to Josh Shapiro's Attorney General races, re-election race, and Governor's race.
- Please provide all e-mail communications, meetings, documents, and All information discussed with the Director of the Pennsylvania Attorney General's Office Bureau of

Consumer Protection, Sarah Frasch, Senior Deputy Thomas Blessington, Attorney General Bruce Beemer, and any supervisors above their capacities to include Josh Shapiro as it pertains to Toll Brothers Inc. Consumer Complaints that should also include the "Requestor" Sean Connolly's e-mails and documents of any kind to include with his former Attorney Jennifer Horn who at one time represented the Connolly's of 124 Kaitlin Dr. Collegeville, PA following her termination of representation stealing confidential case information from the Connolly family regarding the Toll Brothers water intrusion defects.

- Please provide all records, e-mails, memo's, letters sent and received from Jennifer M. Horn Esq. and her business partner Carter Williamson of the Horn Williamson law firm. The records being requested consist of legal matters related to the David Cutler Homes lawsuits and Toll Brothers Inc. consumer complaints logged with the Attorney General's office. The records should include any Toll Brothers Inc. legal evidence that Jennifer Horn engaged in misconduct, stealing the "Requestor" Connolly's legal evidence that pertains to the Toll Brothers water intrusion and defect cases to financially enrich herself while further harming Pennsylvania families. Provide all relative legal information shared with Josh Shapiro, Attorney General Bruce Beemer, Senior Deputy Thomas Blessington before his retirement, his replacement Sarah Frasch, Director Attorney General, Director of the Bureau of Consumer Protection Division and any other relative special agents or attorney that fielded complaints from consumers and any information provided to include communications sent and received from Josh Shapiro to any of his subordinates that involve Toll Brothers Inc. or David Cutler Homes.
- 4. Please provide all inter-office e-mails, meeting agendas, communications, discussions between Sarah Frasch, Director Attorney General, Director of the Bureau of Consumer Protection Division, her supervisors, and any other agents, attorneys as it relates to e-mail communications, and evidence she received from the "Requestor" Sean Connolly of Collegeville, PA from his personal e-mail accounts at verizon. (on file with AG office), tollbrothersconsumerfraud@gmail.com spanning from 2018-2024 present time regarding Toll Brothers Inc., and the hundreds of thousands of dollars if not millions of dollars Josh Shapiro received from this criminally corrupt corporation

spanning more than 1O years and going back to his Montgomery County Commissioner days.

- 5. Please provide all inter-office e-mails, meeting agendas, communications, discussions between Sarah Frasch, Director Attorney General, Director of the Bureau of Consumer Protection Division, her supervisors, and any other agents, attorneys as it relates to e-mail communications, and evidence she received from Channel 6abc investigative reporter Nydia Han, her producer, Heather Grubola, the Philadelphia Inquirer Reporters: Erin Averlund, Caitlin McCabe, or Harold Brubaker.
- Please provide all legal documents, e-mails and evidence supplied to the Pennsylvania Attorney General's Office, and its agents by "Requestor" Sean Connolly of Kaitlin Drive, Collegeville, PA from the time periods on or before 2018 to the 2024 present time.
- Please provide All financial donation records provided by Entities and Individuals to include Toll Brother Inc., Robert Toll, Bruce Toll, Robii Toll, Jennifer Toll, BET Investments aka Bruce E. Toll investments, Toll Brothers PAC's, or any other Toll Brother fanlily members, their attorneys from Cozen O'Conner Law Firm, Penn Biden Center Affiliates, University of Pennsylvania Wharton School of Law, George Soros, Open Society, Mark Zuckerberg, Alejandra Mayorkas, BlackRock, Vanguard, any private person with the last name Shapiro, and ALL other donors from 2017 to 2024 present date and time that donated to Josh Shapiros political campaigns. These records also include ALL "Dark Entities" or Non for Profit donors that donated to Josh Shapiro and he is hiding his donors through Non for Profits for his Governor Race, and Inauguration, all while be abandoned his oath and post with the Pennsylvania Attorney General's office, violating his oaths to Pennsylvanians, his voter bases so he could fund his campaign for Governor.
- 8. Please provide all tax payer records of resources and tax payer dollars used to market, make phone calls from the Attorney Generals office while Josh Shapiro was campaigning for Governor of Pennsylvania to include all costs and expenses from the phone number 717-787- 3391, and e-mails being used by Josh Shapiro www.joshshapio.org, info<@.ioshshapiro.org</p>

- Please provide All records, e-mails, phone calls, text messages, social media chats, memos, letters, of All Attorney General Legal Counsel, Special Agents, BCP reports, orders and other things with detailed directives regarding consumer complaints of Toll Brothers Inc., from 2016 to the present 2024. This should include the total quantity and number of consumer complaints that were lodged with the Attorney General's Office and no action was taken by the agents or if actions was taken by the agents. Please also provide all internal e-mails, memos, letters or NDA 's sent to Consumer Protection Agents to not investigate Toll Brothers consumer complaints from any Attorney General employee, agent, attorney, or Josh Shapiro himself, and where Pennsylvania Attorney General Special Agents have provided information to "Requestor" through a third party detailing the information in 9.) request for information
- 10. Provide any and all communications between Josh Shapiro and the United States Security Exchange Commission of the Eastern District, or in Washington, D.C. and private law firms in regard to an investigational probe for water intrusion False Claims during timeframe of the year 2015 to the present time of the year 2024.
- 11. Please provide all financial records that Josh Shapiro used Special Agents to investigate, intimidate, harass, or threaten Leah Hoopes, and Greg Stenstrom following them reporting Election Fraud to Bill Mcswain former US Attorney. Special Agents: Aida Marcial, and Ben Walton were directed to their homes on Nov 17, 2020 by Josh Shapiro while abusing his position, in attempt to intimidate Federal Witnesses, and Whjstleblowers with using Pennsylvania State Tax dollars. (This request has been verified by more than 2 people and these agents left behind there business cards and were confronted by Greg Stenstrom)
- 12. Please provide the names of any/all investigator(s), assistants, special agents ,involved parties, private law firms, employees, private investigators that were assigned, tasked or participated in any/all investigations that that were discussed, initiated start and end dates of any and all investigations as it pertains to the Toll Brothers Inc. publicly traded company. This should also include any/all employees and or agents that were involved in these matters must be identified, and their names released; and

are not engaged in undercover work, and budgets are not classified.

- 13. Please provide "any and all information, e-mails, phone calls or agents visited Upper Providence Police Department to speak with Detective Patrick Haines, or their Attorney Solicitor, Joseph Bresnan Esq. who recently resigned due to "Requestor" Connelly's ongoing investigations and evidence that he has uncovered, and they are facts to this Right to Know Request.
- 14. Please provide any/all agent or attorney reports, documents, texts, memos, photographs, interviews or any other information that the agency have, maintained, sent, received, deleted or destroyed as it pertains to the Toll Brothers Corporation to include internal agency e-mails.
- 15. Please provide any/all in person meeting dates, names, and title/ capacity of any witnesses that were interviewed during the investigation and the (detailed time frames from when to when). The "Requester" Sean Connolly (is not asking for personal infom1ation), just the name of sources, witnesses, or agents that do not enjoy any legal protections from withholding these public records from the "Requestor" in any attempt to stop, prevent, or cover up their own bad acts, make or made any material misstatements, acts of verifiable recorded fraud. Josh Shapiro was an "elected official" who is held to higher level and his positions are of public trust which is the legal reason why these records do not have legal privilege to withhold from the "Requestor that negatively affect the "Requestor" and Pennsylvanians and the public body they serve.
- 16. Please provide the e-mail Josh Shapiro sent to All Attorney General Agent Supervisors demanding that they get the COVID-19 shots to meet or exceed a 90% metric and to get 90% percent of the work force vaccinated against their will, while also threatening to suspend or withhold vacation requests of supervisor or agents if they did not comply with Josh Shapiros orders to meet the 90% threshold, while Josh Shapiro unlawfully subjected his staff to untested and unproven experimental drug or bioweapon.
- 17. Please provide all communications provided by Mike Verb, and Katie Muth to the Attorney General Josh Shapiro, or now Governor, or Media outlets or any other party before and after

these time frames regarding, any and all things in this right to know request as it relates to Toll Brothers and Josh Shapiro, the COVID shot demand, and the targeted covered up of certain investigations including child rape and molestation cases in Montgomery County, PA so Josh could continue to campaign for higher offices, and still accept financial donations while also accepting money from convicted felons such as John Dougherty, the former head of the local 98 electrical union in Philadelphia and most like many other convicted felons or entities with checkered backgrounds and dark or foreign entities or individuals.

- 18. Please provide all e-mails, memos, directives from any representative working for Josh Shapiro who communicated, or influenced news or media outlets to peddle propaganda, or to peddle lies to Pennsylvanians and to change the opinion of the public and voters. This should include the Philadelphia Inquirer and the existing Chief General Counsel whose wife is a Montgomery County Judge, and friends with Josh Shapiro's wife.
- 19. Please provide all e-mails, memos, directives sent or received by a Dr. Scott Rifkin, who is family friends with Josh Shapiro and his father. Dr. Scott Rifkin who is now part of the Governor cabinet team. Dr. Scott Rifkin was involved in the back door deal with Josh Shapiro, Leslie Richards, and Bruce Castor to sell off 200 acres in Upper Providence PA that was owned by Montgomery County to settle bad county Debt from building a defunct and failed movie studio in Norristown that Josh Shapiro awarded to his friend Dr. Scott Rifkin, to settle a bad deal that Josh, Bruce Castor, and Leslie Richards made behind closed doors without the publics knowledge, all while the county of Montgomery unlawfully denied or were involved in denying right know law requests surrounding the sale, bidders, winning bid while Josh Shapiro was a Montgomery County Commissioner.
- 20. Please provide any/all communications the Pennsylvania Attorney General Josh Shapiro, his agents, employees; or 3rd parties communicated information that negatively influenced, swayed, or interfered, or postured investigations to control outcomes that negatively impacted Pennsylvanians specifically Toll Brothers Inc. consumer fraud complaints, false claims, Election Fraud, cover up of sex assault, harassment and child molestation cases that were reported to him various methods to

include in Facebook messenger apps with a Mother victim, other Mother victims, and children victims of Josh Shapiros double dealings, kids for cash, the MCAP program, and mission kids representatives.

You are hereby notified that the extent or nature of the request precludes a response within the required time period, and additional time is needed to conduct a legal review. As provided in the statute, the Office of Attorney General will require up to an additional 30 calendar days, or until April 24, 2024, in which to provide a final written response to your request. 65 P.S. § 67.902(a). If there are any issues with accessing, redacting, and/or providing the records requested, we will contact you as soon as possible so that you are notified of the problem and we can discuss potential solutions.
